Notification Regarding (Planned) Change in Major Shareholder and Acquisition of the Company's Shares by CNK, Inc.

Sansan, Inc. ("the Company") hereby announces that, as of April 15, 2024, there will be change in its major shareholder, as set out below.

The Company would also like to notify its receipt of a report in which CNK, Inc. stated its decision to acquire shares in the Company, as per the attachment.

This material is disclosed by the Company based on securities listing regulations. Based on a request made by CNK, Inc. (the stock acquirer) to the Company (the company subject to this purchase action), this also serves as a public announcement based on Article 30-1, Paragraph 4 of the Order for Enforcement of the Financial Instruments and Exchange Act.

1. Background to Change

On April 15, 2024, Mr. Chikahiro Terada, the Company's Representative Director, will sell a portion of his shareholding. This is due to the Company having received a report to the effect that Mr. Chikahiro Terada plans to transfer his assets to CNK, Inc., his asset management company.

This will result in a change in the Company's major shareholder.

This acquisition of the Company's shares by CNK, Inc. also constitutes a "buying up specified by Cabinet Order as being equivalent to a tender offer" under Paragraph 1, Article 167 of the Order for Enforcement of the Financial Instruments and Exchange Act and Article 31 of the same Act.
